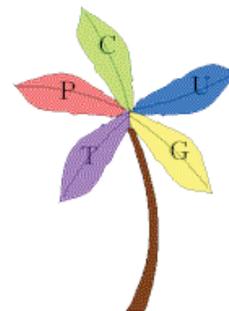

Verizon Wireless Home Connect

I switched my home phone land line to wireless. It's still a home phone, is on the cellular network, but uses no wires. (Actually, there are about ten feet of wires involved).

For background, like many of our members, I have FiOS. FiOS is fibre-optical cabling to the house. It was supplying TV, Internet (25/25) and house phone. I had traditional copper wire until FiOS was installed, and to my surprise they insisted my house phone be switched over to FiOS. I said no, they said yes. It was a package deal, and I agreed to it, so I would have known the details if I'd only read the fine print. So the line was physically patched into the FiOS box, and the copper to my house has been abandoned. Actually that's good. Fibre-optic is much more rugged and reliable than old copper.

The FiOS-supported phone was still a "traditional" phone line in that the calls went to the local switching station that is a part of the local phone network. The next step up is to convert this line to "Digital". This is something that is done remotely – my impression is that it's a computer thing, there are no physical changes – that takes you off the local network. There are two apparent changes when going digital. One is that you must start using the area code even when calling inside your own area. OK. The other change is that your bill will be reduced – my reduction will be about \$6.50 because it will no longer be subject to a federal tax. Actually I have mixed feelings about this. I think when government spending and indebtedness increases, reducing government income isn't the best idea. Duh.

Verizon people on a couple of occasions have "offered" to convert us to a digital home phone, but aside from the \$6.50 monthly reduction, they couldn't present a case for it. I think the advantage is all theirs, and I knew I would lose a couple hours on the phone either getting it to work or getting the billing right. Kind of

like living with the devil. But one person told me that I was going to be switched over to digital within a month or so with or without my participation. I figured if I am going to change, and my billing is going to change, I may as well look at all the options. So I looked at wireless.

Wireless using a cell phone:

Scouring Amazon got me very quickly to a Wireless cellphone/Bluetooth option. There are two types of devices. Both require you to buy a new – or use an old – cellphone with Bluetooth. You add this phone to your cellphone account (everyone has one), and ask that they use your land line number. You put the cellphone down, turn it on, attach a charger to it, leave it on a table and never turn it off. It communicates using Bluetooth with the new device Amazon shipped you. Of the two types of devices, one device is just a black box and has a telephone jack on it. You plug your house phone to that jack. You don't even have to tell your family what you've done, because everything works the same way. The house phone just isn't plugged into the wall anymore. The other option works exactly the same way except that it includes new house phones, and is all in one. It communicates via Bluetooth, has an answer machine built into the base station and one wireless phone. Then – depending on the model, you have one or more – maybe six – handsets placed all over your house that communicate wirelessly to the base station. Mine are made by Panasonic. I've used these for many years with a conventional plug; I'm on my second set that has a base station and three handsets for total of four. I'd have seven except for my policy of never answering the phone from a bathroom. I let it ring until the "survey" company gives up.

OK, so you've just added a cell phone to your family plan, discontinued the land line, reused the home phone number and plugged in your current telephone, and your family doesn't know the difference because you pay the bills – which have gone down because you no longer have the \$30 land line. You've discontinued the inside wire maintenance fee, and lost a federal tax. Your wireless family plan has gone up only \$10/month, and you got a new free flip phone with no features except Bluetooth for free; it can't even take

pictures. Oh, and there is no longer a monthly access fee because you don't need a long distance carrier. That's gone, too.

Here's the bad:

Your new house phone now uses your wireless family minutes. Better keep an eye on that! More on that below.

Last Option – the one I picked.

I'm not sure how I found this. I was looking at the Verizon Wireless phones and plans and stumbled on a tab for “Home Phone Connect.” It is shown in the picture

on the following page.

It's a variation of the other devices I was considering. It has the cell phone built in, hence the antenna. It has a power cube that also charges a battery and two telephone jacks. One of these goes to the Panasonic base station – the same one I've had for many years and like very much. I tried to order this on the Verizon website and gave up, then talked to a couple of Verizon people. It took about an hour-and-a-half on the phone. And that was without talking to the non-wireless people. They FedEx'd the device to me, and since Christmas Day and the day after intervened, it took two FedEx days to get it to me.

We have been using 1/10 of our 700 minutes on three family phones every month. We're not chatty Cathys. But the land line is going to be a different story. I can look at my daily usage online, and also from my smart phone, and I'll be keeping a close eye on it. I can change the plan any time I want by breaking out this phone from my family plan and go to an unlimited local and long distance plan for \$20/month vs. the \$10/month I'm paying now. We'll see. ♦

I plugged it in, attached an old spare wired phone to it and immediately called the number indicated to activate it. The instructions were clear. I could phone out on this, but incoming calls would continue on my land line until Verizon/wired released the land line number. That took three non-holiday/non-weekend days, actually shorter than they warned. Wednesday morning, the regular phone was dead – no dial tone, so I transferred the base station to the Home Connect. It's been working(almost) perfectly since. The cost? The \$129.95 cost was \$49.95 with a two year contract, and a \$35 one-time connect fee. And \$10/month.

One problem – the day after – we determined the Call Waiting wasn't working, and that is important to us. I called *611, got transferred to the Home Connect technician. He reprogrammed it remotely. I assisted by pulling the battery to get it to reboot, and I reactivated it. Then he tested it by calling that number on two phones. Excellent and efficient.

As for my phone apps, I now have eight in the Windows Phone Marketplace. They are making me very little money, but I am enjoying doing them. The main reason for the small return is that I chose to have them display small ads for the ad income and make them free instead of making them paid apps. Now I realize that for ad supported apps, the apps need to be things like games where people stick with them for an extended time. My apps are not “sticky.” You use them for a few minutes and then move to something else.

I entered one of the apps in a contest run by New York City, <http://2011.nycbigapps.com/>. New York City has made much of their data available online and has asked developers to write apps that use it. I chose to use nine of their datasets, such as WiFi locations, parking garage locations and museum locations in my app that places the items on maps with the associated information. Back in November, I got cross-threaded with Verizon and changed to bright house for the Internet. I pretty well got everyone changed over to my Gmail address from the Verizon one. However, bright house didn't offer a free wireless router. Someone said if I had asked they would have provided one. But this seemed OK since I wanted to have my own wireless router. That way I wouldn't have to change things if I switched ISPs again. I have a wireless laser printer, which worked fine on a USB cable, but I wanted it to go wireless as before so my other computers could use it. So I bought a D-Link wireless router model DIR 615. That's when the chaos started.

The router comes with very little documentation, but has a CD with a Wizard program to install it. The Wizard is maybe for more advanced users than I because I could never get the router properly installed using it. Finally, after contacting their technical support, we resolved the problem. I was letting the computer generate a security key. I would copy it to a thumb drive, paste it in the net card on the other computer and it would not work. Finally, the tech guy said to put in a manual key, and that worked. Now I could talk to the Internet from every computer – great!

The next project was to make the laser printer wireless and accessible from all computers. I went through the wireless set-up Wizard with no luck. I called for Samsung tech support and was walked through the set-up by addressing the printer via its network address. The Samsung tech support is great! All went well. I was able to access the printer from all computers that

day. However, the next day the printer was no longer available! After much fiddling I discovered it had changed its network address all by itself! So I reinstalled it again with the new address. After that didn't work, I called tech support again. The change that fixed the problem was changing the TCP/IP type from DHCP to STATIC. If I understood him correctly, he said every time the printer is turned off and on again, it would use a different network address. Why would anyone do that? Anyhow, after much de-installing and reinstalling, we got it working from all computers again. So far I have powered off and on the printer and computers several times and everything still works. So I told myself welcome to the wireless world. Another way to spend hours fixing things to save time using computers. ♦
